## REQUIRED UNIFORM & EQUIPMENT

Each recruit shall have the following equipment in order to participate in the Law Enforcement training program administered at the Ocean County Police Academy.

- (2) Long Sleeve Khaki Shirts
  - Academy Patch on Left Breast Pocket
  - Department Patch on Right Shoulder
  - SLEO I or II Patch on Left Shoulder (if applicable)
- (2) Khaki Trousers
- (2) Black Ties
- (1) Black Leather Belt
- (1) Black Leather Low-Cut Military Shoes (no patent leather or Corfam shoes)
- (2) Pairs of Black Crew Socks
- (1) Black Baseball Cap (FlexFit style with no logo)
- (1) Black Tru-Spec H2O Proof Gen 2 Parka #2027\*\*
- (1) Black Tru-Spec Polar Fleece Jacket #2434\*\*
- (1) Black BDU Trouser (for Firearms Training)
- (1) Silver Metal Name Plate (First Initial, Last Name)

\*\*If the Tru-Spec items are unavailable, substitute with  
- Propper 3-in-1 Hardshell Parka, Black #F5436

### Physical Training Uniform & Equipment

- (2) Navy Blue Sweat Pants
  - Last Name 2" Gold Letters across the rear seat
- (2) Navy Blue Sweatshirt (Plain Pullover Crewneck)
  - Last Name 2' Gold Letters across chest and back
- (2) Navy Blue T-Shirts
  - Last Name 2" Gold Letters across chest and back
- (2) Navy Blue Shorts
  - Last Name 2" Gold Letters across rear seat of shorts

- (1) Black Wool Watchman Hat
- (1) Pair Black Athletic Gloves (unbranded)
- (1) Pair Running Shoes
- (4) Pairs All White, Crew Height Athletic Socks
- (1) Bath size White Towel
- (1) Indelible Black Laundry Marker
- (1) Template (2" Letters)
- (4) Chrome Wire Coat Hangers

**NOTE: BRING ALL LISTED EQUIPMENT ON THE FIRST DAY OF PHYSICAL TRAINING.**

#### **FIREARMS EQUIPMENT & SUPPLIES:**

- (1) Department Issued Service Weapon with 3 Magazines
- (1500) Rounds of New Factory Loaded Practice Ammunition (must meet definition of equivalent load)
- (12) S.T. Pro Action Pistol Dummy Rounds or equivalent (appropriate caliber)
  - Must have **Metal Case** with plastic tip
- (1) Pair of Firearms hearing protection
- (1) Pair of Wrap Around eye protection
- (1) Handheld Flashlight

**NOTE: AGENCIES WITH WEAPON-MOUNTED LIGHTS MUST HAVE A HANDHELD FLASHLIGHT AS WELL. WEAPON MOUNTED LIGHTS MUST BE AVAILABLE FOR WEAPONS INSPECTION AND ALL FIREARMS TRAINING.**

#### **FIREARMS EQUIPMENT & SUPPLIES CONT.**

- (1) Duty Belt
- (1) Duty Holster\*\*
- (1) Duty Magazine Pouch
- (1) Blue Gun, which is equivalent to Department Issued Pistol
- (1) Gun Cleaning Kit

**NOTE:** Duty belt, holster, magazine pouch and Blue Gun **MUST BE AVAILABLE ON 1<sup>st</sup> DAY OF CLASS. All other Firearms related equipment must be available for inspection 4-6 weeks prior to Firearms training. Each agency is required to provide each recruit with a handgun. Recruit are NOT allowed to share handguns.**

**\*\*Auto lock-trigger finger release style holsters are prohibited. (Example – Blackhawk Serpa)**

#### **DEFENSIVE TACTICS EQUIPMENT**

- (1) Set of 4 oz. MMA gloves
- (1) Padded head guard suitable for MMA
- (1) Mouth guard
- (1) Set of athletic footwear other than your outside PT footwear (wrestling shoes, sneakers, training footwear acceptable. **NO BOOTS ARE ALLOWED ON MATS**)

**\*\*THESE ITEMS ARE REQUIRED FOR DT TRAINING**

**AND SHOULD **NOT** BE BROUGHT INTO THE ACADEMY EXCEPT ON DT TRAINING DAYS\*\***

#### **MISCELLANEOUS EQUIPEMENT:**
